# The privilege of the floor to the public: (A motion to limit debate could be in order)

- Jane Rose - Food Pantry

Mrs. Rose Thanked the Supervisor and Board members again for their support of the Food Pantry. She thanks Councilwoman Ritz for giving the food pantry report at the last board meeting. Mrs. Rose gave the town clerk a new qualifier sheet to upload to the Town website. She asked the board if they could put security cameras on the food pantry building. The food pantry will buy the cameras, they just need them put in. She also asked if there could be wifi internet installed in the building and could Supervisor Smith look into if the food pantry falls under the Town's insurance. She is worried if the power goes out, and they lose their frozen foods, how would they replace it? Superintendent Langs stated the Village had a portable generator that could be put in for the food pantry. He stated he would get a quote from Bobbie Weeks for installing a transfer. Supervisor Smith stated he would talk to the town insurance company and get back to her. Mrs. Rose also let the Supervisor and board members know that ice came off the roof and knocked the donation box for the food pantry off the building. She wanted to know if a roof or cover could be installed to prevent this from happening. She thought maybe the cost could be split between the Town of Diana and Town of Pitcairn, since the pantry services both communities. Supervisor Smith stated he would talk to Allison to see if the costs could be split. Supervisor Smith thanked her for coming and stated he would get back to her soon with answers to her questions.

At 6:30 pm, Supervisor Smith called a pause to the Regular Board Meeting to go back to vote and adjourn the Public Hearing for Local Laws

- Grant update on zoning Grant application not accepted for GateWay Grant
   Supervisor Smith informed all that the Town of Diana was denied the grant a second time,
   because only 20% of the town is in the Adirondack Park. They are looking for another option.
- Harrisville Health Center Review the Draft Lease agreement with Attorney Hassler Supervisor Smith let all present know that the Town of Diana Attorney, Lawrence Hasseler had drawn up a new lease. Mr. Hasseler explained he used the previous lease from the medical building, made a few changes, but basically the lease remained the same and asked the board members to review the lease. Mr. Hasseler stated that with the hospital providing medical service to the town it is considered fair market value so the lease amount would be \$1.00. He also stated he included an early termination clause with 108 day notice required. The hospital would put in the times for hours of operation and days of operation. Supervisor Smith asked for a motion to approve the lease being sent to the Director of the Lewis County Hospital for his review. Councilman Bango asked for time to read the lease over before approving it. Mr. Bruce Bango stated"take 20 minutes and read it then." Councilman Bango stated he didn't want to hold up the meeting for 20 minutes while he goes over the lease. Councilman Pierce stated that they needed to approve this lease now, or we risk the hospital backouting out of the deal. Representative Frost stated he did not feel that the hospital was going to pull out of the deal. Councilman Pierce stated that they already had two picks to come into the building and if the town drags their feet any longer we risk the hospital backing out of this deal. Councilman Bango asked Councilman Pierce why he seemed to know so much more about this than the rest of us and those who we voted to handle the negotiations. Councilman Pierce stated because he talks to Doctor Shambaugh. Councilwoman Ritz stated she felt the board approving that Supervisor Smith send the lease to Lewis County Hospital shows Gerald Cayer that the Board is acting in good faith and wants to have Lewis County lease the medical building. Supervisor Smith asked the board again for a motion to send the lease asking them, "do I have the board's permission to send the lease to the director at Lewis County Hospital, so he can go over the lease, and if he makes changes, can get it back to me so we can finish negotiations." Councilman Pierce further stated that he feels, once the lease comes back from the Director at Lewis County Hospital the board should call a special meeting to approve the lease and move forward once the hospital agrees to the lease.

Supervisor Smith asked again for a motion to allow him to send the Lease Agreement for the Town Medical Building to the Director of Lewis County Hospital, Gerald Cayer, and call a special board meeting once the lease comes back from Mr. Cayer, to be able to approve the lease or not.

Broadcasting meetings on YouTube (Tabled January) - Thoughts on recording: Supervisor Smith asked the board members how they felt about recording equipment verses broadcasting the board meetings through a free service. Councilwoman Ritz said no, that isn't what the people want. The Town Clerk asked if she could address the board. Supervisor Smith stated yes. Mrs. Paterson stated that the video broadcast of the previous meetings that Mrs. Ritz did before being elected back onto the board were very helpful to her, and that while digital voice recordings would be helpful, they will not protect the town in the event of a lawsuit. With a digital voice recording of the meetings, you hear only the voice and don't see the actions. It is also easy to not be sure on a recording who is saying what. The free video broadcasting is a better protection for the town and members of the audience. She further explained the Town of Manlius, Town Supervisor John Deer did training at the Clerk's convention and told us how their video broadcast recording saved the town from losing a lawsuit. The judge told him that had they only had the typed minutes, and he had not been able to see who was speaking and the behaviors and body language, he would have ruled in favor of the plaintiff and the town would have lost the lawsuit. The clerk stated that she has had calls from some of our older residents asking why the meetings were no longer being broadcast. Councilwoman Ritz also stated that it is part of what she ran on, transparency and letting the residents see the board members at work. Supervisor Smith added that there are many that work out of town and don't get back in time for our board meetings, snowbirds that are gone during the winter and summer residents who like to watch to know what is going on in the town. It is a free service. To go with digital voice recordings we will have to pay for equipment to do this. Supervisor Smith called for a motion to live stream the board meetings.
